We have now directly served over 120 families in Bibb and Jones Counties since 1986 with over 50 of these families living in Lynmore Estates and two in Pleasant Hill. The organization celebrated mortgage burnings with 2 Habitat families who have paid off their homes. Continued success of the ReStore contributed over \$140,000 in sales to further our mission. The second half of this fiscal year was impacted by the global COVID-19 pandemic. The Macon Habitat Board of Directors enacted COVID-19 closures and reduction in staffing in beginning March 2020 with many lasting through the end of the fiscal year. These guidelines included the closure of the ReStore, cancellation of the Making Dreams Come True fundraiser and the cancellation of all volunteer groups.

As MAHFH collects the mortgage principal payments for the homeowners, the Organization remits those payments quarterly to the government. These funds are then restricted by the government to be available for future NSP and HOME eligible projects. The other decrease in net assets totaling \$81,480 represents the total amount remitted to the government for the NSP and HOME related homes during the year ended June 30, 2020.
